1. Army Public School invites expression of interest from experienced and potential service providers through sealed bids under two bid system i.e. Technical Bid & Financial Bid for repair of two existing basketball courts at Army Public School Beas, presently functioning in its campus at village Gazi Gadana, P.O. Dhilwan, Distt. Kapurthala.

2. The interested agencies may visit the institute site (www.apsbeas.org) before filling the tender documents during office hours from 10.00 a.m. to 4.00 p.m. to have a preview of the existing condition of the basketball courts.

Eligibility :-

1. The tenderer should have an experience of constructing the sports infrastructures of national and international standard.

2. The tenderer must have the willingness for providing comprehensive maintenance support of the, system supplied by him.

3. The tenderer must provide evidence of successful execution of such orders with instalation and successful after sales support in reputed organisation.

4. Should possess requirements such as GST registration, PAN Card etc.

5. Sealed EOI document shall be dropped in "Two parts" i.e., (Technical and Financial Bid) for repair of two existing basketball courts in the box placed at Main Gate of Military Station, Beas.

6. The EOI document has been uploaded in the Army Public School website http://www.apsbeas.org The willing and eligible bidders can download it from the website and should attach a separate DD/Pay Order of Rs. 500/- (Non-refundable) issued by any nationalized/commercial bank after the date of publication of this notification, as tender processing fee in favour of Principal, Army Public School Beas, payable at Beas, along with the technical bid document. The document without the tender processing fee will not be considered and straightway rejected.

7. The tender document complete in all respects is required to be submitted along with the E.M.D. of Rs. 25,000/- (Rupees twenty thousand only) in the form of D.D. drawn in favour of Principal, Army Public School Beas, payable at Beas. The EMD in the form of DD should be kept with the Technical Bid (DD should have been issued by any nationalized/commercial bank after the date of publication of this notification). No exemption of EMD is applicable. Any document without the EMD with technical bid will not be considered and straightway rejected. EMD of unsuccessful tenders will be refunded.

Bids will not be received if sent through Regd. / Speed Post / Courier or by E- mail.

2. The Technical and Financial Bids should be kept in separate sealed covers, with "Technical Bid" and "Financial Bid" super scribed on the envelope. These two sealed covers may be kept in another sealed cover along with the tender documents, with "Tender for repair of two existing basketball courts" at Army Public School Beas super-subscribed on the envelope. The name and address of the Agency/Firm must be mentioned on each envelope.

3. The Technical Bids will be opened on **08 Mar 2024** 1230 hrs. at Military Station, Beas by the tender committee of Army Public School, Beas in the presence of the tenderers or their authorized representatives. The Bids documents submitted shall be scrutinized through, two stage evaluation process. After evaluating the Technical Bids, the eligible bidders shall be shortlisted for second stage Financial Bids evaluation. The date to open the Financial Bid will be announced later telephonically to the eligible bidder.

4. Tenderers are required to visit the institute website regularly for updates. Incomplete tenders and those without proper tender fee and E.M.D. shall be summarily rejected.

5. Warranty period, construction period and after sale service conditions etc are also be clearly indicated.

TERMS AND CONDITIONS FOR AWARD OF CONTRACT FOR REPAIR OF TWO EXISTING BASKETBALL COURTS FOR THE STUDENTS OF ARMY PUBLIC SCHOOL BEAS GAZI GADANA, PO DHILWAN, DISTT KAPURTHALA

1. The contract will be awarded only to the overall successful bidder with lowest construction cost without any compromise on the quality.

Note :

(a) Tenders shall be submitted in official tender form only. If submitted in any other form the same shall be summarily rejected.

(b) No tenderer shall be issued more than one tender form.

(c) Tenders received without prescribed Earnest Money Deposit (EMD) shall not be considered.

(d) No paper shall be detached from the tender after submitting the tender with the Institute.

(e) The name and address of the tenderer shall be clearly written in the space provided and no overwriting corrections, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein otherwise the tender is liable to be ignored.

(f) The tender is liable to be ignored if complete information is not given there in or if the particulars and date (if any) asked for in the Schedule to the tender are not filled in.

(g) The bids should be valid in the case of all the tenders for at least 3 months from the date of opening of the tender and if any bidder withdraws or alters the terms of the tender during the period, the Earnest Money Deposit shall be forfeited. In the case of the successful bidder, rates quoted shall be valid for the entire period of the contract or as mutually agreed upon in case of any changes.

(h) Corrections, if any, must be attested.

(j) Late tenders will not be considered.

(k) The constructor/tenderer shall be further responsible for proper discipline for the employees engaged by him and their work besides observing other obligations.

(I) No child labour shall be permitted by Army Public School Beas under this contact. Further the service provider shall be responsible to pay all the dues of employees, as well as statutory dues applicable under labour laws. In the event there is any violation of any contractual or statutory obligations regarding the Personnel / labour, the service provider shall be responsible and liable.

(m) Army Public School Beas shall in no way be responsible for any default with regard to statutory obligation and the constructor/tenderer will indemnify Army Public School Beas in case of any damage, which may arise on account of action of constructor/tenderer.

(n) All work shall be carried out with due regard to the convenience of Army Public School Beas the orders of the concerned authority shall be strictly observed.

(o) The constructor/tenderer shall be fully responsible about the conduct of his employees and shall ensure that their behavior with the students, supervisors, officers is always good and cordial. If it is found that the conduct or efficiency of any person employed by the constructor/tenderer is satisfactory, the constructor/tenderer shall have to remove the person concerned and engage a new one within (48) hours of intimation. The decision of the so Designated Officer in this regards shall be final and binding on the constructor/tenderer.

(p) The workmen employed by the constructor/tenderer shall be directly supervised and controlled by the constructor/tenderer and shall have no relation whatsoever with Army Public School Beas. The Institute shall have no power to control or supervise such workmen or to take any action against them except as permissible under law. Such workmen shall also not have any claim against Army Public School Beas for service or legalization of services by virtue of being employed at Army Public School Beas against any temporary or permanent posts at the Institute.

(q) The work executed shall be to the satisfaction of Army Public School Beas.

(r) The constructor/tenderer shall ensure that either he himself or his representative is available for proper Administration and supervision at the works.

(s) Warranty period construction/delivery period and after sale service conditions etc are also to be clearly indicated.

(t) The rates and the conditions of the offer will be valid for three months from date of opening of the tender and no change or alteration of the rate will be acceptable on any account.

(u) Submitted tender forms with overwriting or erased or illegible specifications and rates will be rejected.

(v) Tenderers shall carefully examine the bid documents and fully inform themselves of all the conditions which may in any way affect the work of the cost thereof.

(w) Should a tenderer find discrepancies or omission from the specification or other documents and any doubt as to their money, he should at once notify the purchaser and clarification in writing.

(x) In case the rates quoted by the tenderers are very high or do not suit to the school management the negotiation may be undertaken for reducing the quoted rates.

Requirements by tenderer after supply :-

- (a) The material would be delivered by the supplier at Army Public School Beas.
- (b) Goal posts/ poles should be supplied directly from the manufacturer/ authorised dealer having passed all test successfully with certifications as required.

(c) The construction should conform to the latest relevant national/international standards and shall be completed in all respects.

(d) Any component, fitting etc, which may not have been specifically mentioned in the specifications but which is usual and necessary for the equipment, shall be supplied by the tenderer at no extra cost.

- (e) The equipment shall be delivered and installed at sight at cost of the tenderer.
- (f) All taxes, levies and surcharges including the customs clearance and handling freight and insurance should be paid and handled by the tenderer.

Construction on installation and commissioning :-

Installation and commissioning Shall include the following :-

(i) Installation and testing of the system should be supplied by the tenderer.

(ii) It is the responsibility of the tenderer to provide all necessary spares, consumable and raw materials which may be required during installation and commissioning at no extra cost.

(iii) The tenderer is to bring their own testing and measuring instruments required for installation, testing, commissioning, which can be taken back after completion.

After Sale Service :-

During the warranty period the tenderer Shall attend to the problems reported by the users, on priority basis

Penalty :-

If the construction is not carried out in time as specified in other part of the tender document, the tenderer will be charged 0.5% per week of the total value of concerned project cost and not more than 10% of the total cost of the project.

Payment :-

No advance payment will be given to the vendor. Total payment will be paid on completion of the work after inspection and approval by Board of Officers.
